RELEASE AND WAIVER OF LIABILITY

In consideration of the Indiana Department of Transportation ("INDOT") granting permission to me to be a participant in the Adopta-Highway Program (hereinafter referred to as the "Program") for the sole and exclusive purposes of enhancing public awareness regarding littering, promoting the enhancement and beautification of the State of Indiana, and engaging in community outreach, I, on behalf of myself and my guardians, heirs, representatives, successors and assigns (if any), hereby agree as follows:

- 1. I release, waive and covenant not to sue the State of Indiana and all of its agencies, officials and employees (including INDOT, collectively the "Released Parties"), from any and all liability and claims (including but not limited to claims of negligence, claims of negligence of the Released Parties, claims arising out of or in any way related to any act of the Released Parties and/or claims arising out of or in any way related to any failure to act by the Released Parties), actions, causes of action, demands, rights, damages (including, but not limited to, consequential, incidental, compensatory, punitive and/or exemplary), debts, accounts, attorney's fees, costs, liens, dues, expenses and compensation of all kinds, known or unknown, foreseen and unforeseen, which may arise out of or be related in any way to my participation in the Program, including without limitation any act, or failure to act, by the Released Parties. I understand the inherent dangers associated with walking along U.S. highways and State highways and waive any and all specific notice of the existence of such dangers.
- 2. I hereby assume all risks in any way growing out of, arising out of or in any way relating to my participation in the Program. I assume these risks, whether the risks are known or unknown. I understand and agree that I will be solely responsible to comply with all safety measures, recommendations, and instructions during the event and while present on state property. Such safety measures, recommendations, and instructions may include but are not limited to the use of personal protective equipment (PPE) and compliance with all recommendations of local and state health officials or national guidance from the Centers for Disease Control.
- 3. This release and waiver of liability represents the complete understanding between INDOT and the undersigned regarding these issues and no oral representations, statements or inducements have been made apart from this document. If any provisions herein are held to be unlawful, void, or unenforceable, then that provision shall be deemed severable from the other provisions and shall not affect the validity and enforceability of any remaining provisions.
- 4. I understand that I am not being allowed as a participant in the Program for any other purpose except for that explicitly identified herein.
- 5. This release and waiver is in effect from the date of signature through the date of participation in the Program, if the date of participation in the Program is after the date of signature. I understand that I will be required to execute a new release and waiver each time I choose to participate in the Program. I further understand that I will not be allowed to participate in the Program until INDOT receives my fully executed release and waiver.
- 6. I EXECUTE THIS RELEASE AND WAIVER AS A FREE AND VOLUNTARY ACT AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
